- ii) Only those students who complete the programme shall be eligible to get "Character Certificate" and "Migration Certificate" from the institute on demand.
- iii) All the students who enroll in their respective P.G. /Ph.D. programmes with Institute assistantship shall have to submit an "undertaking" as stipulated on a prescribed format (on a non-judicial stamp paper of Rs. 50/- duly signed

Further, it was decided that the concerned DUGC of the department shall evaluate the Internship undertaken by the student based on the following sub-clauses of clause 12:

(i) In case of Academic Institutions; the provisions clause 12(e) of UG Regulations shall be applicable if the students does course work. However, if the students does project/internship then clause 12 (f) of the UG Regulation shall be applicable.

In case of R&D Organizations/Industries; clause 12(f) of the UG Regulation shall be applicable.
