Shri Pramod Kumar Agarwal, Member, BoG could not attend the meeting and requested leave of absence, which was accorded to him by the Chairperson.

At the outset, the Chairperson welcomed the members to the 53rd Meeting of the Board of Governors.

The Director, with the permission of the Chairperson, informed the Board of the significant achievements and activities undertaken at MNIT, Jaipur in the previous three months, these include:

- In the NIRF rankings 2023 MNIT, Jaipur has made remarkable progress in engineering rankings, jumping 9 positions and currently occupying the 37th rank. In the overall category ranking, MNIT, Jaipur has surged ahead by 29 positions now standing at the impressive 62nd position, MNIT, Jaipur has achieved recognition as one of the top 50 research institutes in the country, securing an impressive 47th rank. Standing at the 6th rank across all NITs, MNIT secured the 13th rank in the Architecture and Planning category.
- MoU signed between the National Dam Safety Authority, Ministry of Jal Shakti, Government of India, New Delhi and the Malaviya National Institute of Technology, Jaipur, recognizing the National Centre for Disaster Mitigation and Management, MNIT Jaipur as the National Centre for Earthquake Safety of Dams whereby the Ministry of Jal Shakti, Government Of India, has sanctioned a Financial Grant of Rs. 30 Crores for establishing and running the Center for 5 years.
- Organizing the National Stakeholder Workshops at MNIT Jaipur by the Department of Science and Technology (DST) and Bureau of Energy Efficiency (BEE), Ministry of Power, in collaboration with IIT Palakkad Technology IHub Foundation (IPTIF), MNIT, Jaipur and IIT Roorkee.
- Adoption of a new model for optimal and efficient utilization of the Grant in Aid under the Grant Head OH-35.
