Along with the above, the following directives be adhered to:

- 1. Distribution tabulated above shall be reviewed after 5 years.
- The posts are to be filled up as per conditions prescribed in the Recruitment Rules
 in force at the time of occurrence of vacancy/ vacancies unless the recruitment rules
 are amended retrospectively.
- 3. An employee will be considered for promotion only when (s)he is regularly selected on the post from which promotion is to be made. Ad hoc period of service will not be considered for the purpose of computing her/his service.
- 4. Promotion will be considered from feeder grade post(s) to higher post in the hierarchy as per the provisions of the applicable Recruitment Rules for non-teaching staff in NITs. Further, it is also compulsory to ensure that the employee(s) considered eligible for promotion must adhere to the number of years of qualifying service and required qualification laid down in related recruitment rule for a post.
- 5. Employees in Technical Higher Cadre recruited before Advt. No. : AES/MNIT/ESTT/2023/01 Dated 22.03.2023 will be considered for promotion on combined sanctioned post in Technical Higher Cadre with 11 number of posts at Pay level 6 (Technical Assistant, SAS Assistant, Library & Information Assistant and Junior Engineer), 42 posts at Pay level 7 (Sr. Technical Assistant, Sr. SAS Assistant, Sr. Library & Information Assistant and Assistant Engineer), 28 posts at Pay level 8 (Technical Assistant-SG II, SAS Assistant- SG-II, Library & Information Assistant-SG II and Assistant Engineer-SG-II) and 14 posts at Pay





level 9 (Technical Assistant-SG I, SAS Assistant- SG-I, Library & Information Assistant-SG I and Assistant Engineer-SG I) respectively on combined seniority finalized by the committee constituted vide Office Order No. F6 (1)/MNIT/08/Pt-II/1344 dated 18.01.2017. Employees recruited against Advt. No.: AES/MNIT/ESTT/2023/01 Dated 22.03.2023 and thereafter will be promoted in hierarchical structure defined for each post in feeder cadre viz Technical Assistant, SAS Assistant, Library & Information Assistant and Junior Engineer.
