**Resolution No. BOG-58-1/2025/12**. The Board of Governors approved the cases of Vishal Kumar (2011PST5125) for the award of M.Tech. (Structural Engineering) degree and Ravi Rathi (050362) for the award of B.Tech. (Electronics and Communication Engineering) degree.

Item No. 58-5.13: To consider the uniform policy / guidelines for working of various existing and upcoming Centres at the Institute

**Resolution No. BOG-58-1/2025/13**. The Board of Governors approved the uniform policy / guidelines for various centres operating at the Institute.

Item No. 58-5.14: To consider the revised allowances permissible to students /coaches participating in sports events outside the Institute.

**Resolution No. BOG-58-1/2025/14.** The Board of Governors approved the revised allowances permissible to students /coaches participating in sports events outside the Institute as mentioned below:

- 1. Daily Allowance (DA): Each participating student shall be entitled to Rs. 625/- per day, inclusive of pocket money and food expenses.
- 2. Travel Allowance: Travel by Third AC may be allowed with approval from the Competent Authority.
- 3. Air Travel: In exceptional cases (e.g., non-availability of train tickets, emergencies, safety concerns, or prolonged travel exceeding six days), students may travel by air (economy class, shortest route) with prior approval from the Competent Authority.
- 4. **Sports Kit Allowance:** Each participating student will be entitled to a single sports kit annually, with a cost cap of Rs. 3,500/-, irrespective of the number of tournaments attended.
- 5. Medical Expenses During Tournaments: In case of a medical emergency or accident during a sports tournament, financial aid of up to Rs. 50,000/- may be provided as per actual expenses incurred. The student's health insurance coverage will be utilized first, and any shortfall will be covered by the institute with a maximum capping of upto Rs. 50,000/-.
- 6. Registration Fees/Officiating Charges: These charges will be borne by the institute as per the actual amount for various tournaments.
- 7. Miscellaneous Expenditures: The maximum permissible budget under the "Miscellaneous" head shall be:
  - Rs. 10,000/- for a total budget below Rs. 2,00,000/-.



- Rs. 25,000/- for a total budget above Rs. 2,00,000/-.
- Expenses under this head will be reimbursed on actual basis only.
- 8. **Norms for Coaches:** The above allowances shall also apply to empaneled coaches accompanying students during the sports tournaments.
- Budget Allocation: All expenditures related to these sports activities shall be charged under the budget head "Creative Arts & Sports."

### Item No. 58-5.17: To consider creation of a new department at the Institute namely Department of Energy

**Resolution No. BOG-58-1/2025/17.** The Board appreciated the proposal presented by the concerned Heads. Resolution No. BOG-58-1/2025/19. The Board of Governors approved the proposal for replacing the existing old overhead electrical supply line with underground cable & street light work in the MNIT Jaipur at an estimated cost of INR 4,98,86,034/-. The above expenditure shall be met from grant-in-aid; if the grant-in-aid is not sufficient, the expenditure shall be met from the Institute IRG.

### Item No. 58-5.20: To consider the additional electrical & mechanical work in 320 bedded Chandra Shekhar (EWS) boys hostel at MNIT Jaipur.

The Board was informed, that the requirement arose owing to the need for the addition of the following services that were not included in the original estimate:

- a) Wi-Fi system
- b) Two nos. 16 passenger lifts
- c) Substation equipment-500kVA Dry type transformer

Resolution No. BOG-58-1/2025/20. The Board of Governors approved the proposal for additional electrical & mechanical work in 320 bedded Chandra Shekhar (EWS) boys hostel at MNIT Jaipur at the estimated cost of INR 3,03,11,676/-. The above expenditure shall be met from the Institute IRG.

The Board directed the Institute to take up the matter with CPWD so that such variations can be avoided in future. The Board further advised the BWC to go for the approval of projects only after the receipt of the drawings and comprehensive DPR in order to avoid subsequent additional approvals.

### Item No. 58-5.21: To consider the revised estimate for construction of the 600 bedded Boy's Hostel (Aravali Hostel).

**Resolution No. BOG-58-1/2025/21**. The Board of Governors approved the proposal for construction of the 600 bedded Boy's Hostel (Aravali Hostel) at the revised estimated cost of INR 52,03,56,842/-. The above expenditure shall be met from the Institute IRG.

The Board directed the Institute to take up the matter with CPWD so that such variations can be avoided in future. The Board further advised the BWC to go for the approval of projects only after the receipt of the drawings and comprehensive DPR in order to avoid subsequent additional approvals.

### Item No. 58-5.22: To consider the proposal for expansion of Primary Health Centre at MNIT campus Jaipur.

The Board was apprised that a preliminary estimate has been submitted by CPWD for expansion of Primary Health Centre for the following facilities:

- 3 additional consultation rooms: 600 sq. ft.
- 2 additional wards (18-20 beds):1200 sq. ft.
- 2 additional dispensing/first aid rooms: 400 sq. ft.
- Surplus area for waiting room: 2000 sq. ft.
- 1 additional Store room: 200 sq. ft.
- Additional toilet space: 600 sq. ft.
- Laboratory space: 500 sq. ft.
- Space for Physiotherapy center hall: 800 sq. ft.
- Pharmacy space (with additional store room): 400 sq. ft.



**Resolution No. BOG-58-1/2025/22**. The Board of Governors approved the proposal for expansion of Primary Health Centre at MNIT campus Jaipur at an estimated cost of INR 5,15,18,104/-. The above expenditure shall be met from grant-in-aid; if the grant-in-aid is not sufficient, the expenditure shall be met from the Institute IRG.

Item No. 58-5.23: To consider the proposal for construction of 56 Type-III quarters for administrative and technical staff of MNIT Jaipur.

Resolution No. BOG-58-1/2025/23. The Board of Governors approved the proposal for construction of 56 Type-III quarters for administrative and technical staff of MNIT Jaipur at an estimated cost of INR 29,89,00,000/-. The above expenditure shall be met out of funds obtained through HEFA loans.

Item No. 58-6.0: Any other item(s) with the permission of the Chair

Matters for consideration of the Board of Governors.

### Item No. 58-6.1: To consider the construction of entrance plaza along with the new road construction and parking.

The Board was informed that the construction of entrance plaza was approved by the BoG with an estimated cost of INR 4.95 Crore. The original plan was to construct an entrance plaza at the existing main gate of the institute. However, the local authorities are now planning a flyover which is likely to go beyond existing gate, thus reducing direct accessibility and visibility of the gate. In light of this, CPWD has submitted a revised preliminary estimate as per the revised drawing and design for construction of entrance plaza.

**Resolution No. BOG-58-1/2025/24**. The Board of Governors approved the proposal for construction of entrance plaza at a revised estimated cost of INR 13.69 Crore arising due to additional work including construction of a new road and parking.

### Item No. 58-6.2: To consider the matter of award of INR 7,52,16,651/- for the project construction of 884 bedded Girls Hostel for MNIT Jaipur.

The Board was informed that the construction project for an 884-bedded Girls' Hostel, approved by the BoG, had an estimated cost of INR 86,17,88,200/-. The project contractor initiated arbitration proceedings, resulting in an arbitration award of INR 7,52,16,651/-. Subsequently, CPWD challenged this award in the Commercial Court. The Hon'ble Court granted a stay on the execution of the award, subject to the condition that 50% of the awarded amount, including interest, i.e. INR 4.50 Crore be deposited within 60 days from the hearing date, i.e., January 3, 2025. The Board of Governors approved the same.

**Resolution No. BOG-58-1/2025/25.** The Board of Governors considered the recommendations of the Finance Committee and approved the award of INR 4.5 Crore towards arbitration proceedings.
