Minutes of the 29th Meeting of the Board of Governors

The 29th Meeting of the Board of Governors was held on 19th January, 2014 at 2:30 P.M. in the Meeting Room, NIT Guest House, Safdarjung Enclave, New Delhi. Following were present:

At the onset, the Director welcomed the Chairman and other members present in the meeting. Subsequently the Secretary, BoG took up the agenda items for discussions and the following decisions were taken.

Item No. 29-1.0:

To confirm the minutes of the 28th meeting of the Board of Governors held on 22nd December, 2013.

Based on award of earlier CAS (Senior Scale) and decision of standing committee of NIT council circulated vide letter no. 1089 dated 29/10/2013, the Board agreed in principle to consider Dr. Subir Debnath as faculty, however he has to surrender the benefits earlier taken under MACP.

The Board also felt that for better career prospectus, Dr. Debnath may be in non teaching staff since CAS stands discontinued and there is no possibility of further career advancement of Dr. Debnath as faculty. It was decided that Dr. Debnath may be asked to make his choice for being considered as faculty or non faculty.
