At the outset, the Chairman welcomed the members to the Special meeting of Board of Governors and introduced the following new members nominated by the Government of Rajasthan who were attending their first meeting in his opening remarks:

Pursuant to the Chairperson's opening remarks, the Board took up the agenda items for discussion and decisions.

Item No. SPL-1.0: Items for consideration

Item No. SPL-1.1: To consider the Reservation Roster of various faculty cadres.

The Reservation Roster of various faculty cadres was presented to the BoG. The Board was apprised of the vacant positions as approved by the BOG vide its item no. SPL-1.3 of Special BOG meeting held on 15th July 2022. Earlier, the vacancy position was calculated on the basis of three types of posts Professor, Associate Professor, and Assistant Professor (merged the levels 10, 11, and 12). The Roster Committee and Nodal officers of SC/ST/OBC cells of the Institute recalculated the vacant positions on the basis of Assistant Professor at the level of 10, 11, and 12 separately without affecting the total vacant positions, which was also accommodated by ACoFAR in its meeting held on 7th November 2022.

Resolution No. BoG-SPL-2/2022/02: The Board considered and approved the draft advertisement for recruitment to various faculty positions and directed that the matter be considered subject to compliance of provisions contained in RRs and Reservation Roster. The Board emphasized the need for maintaining efficiency and speed in the recruitment process while simultaneously ensuring high quality of the personnel thus recruited.

Item No. SPL-2.1: To reconsider the grievance of Technicians and Senior Technicians regarding their promotion through DPC in 2019.

Resolution No. BoG-SPL-2/2022/03: The Director apprised the Board of the grievance of Technicians and Senior Technicians regarding their promotion through DPC in 2019. The board directed that the matter be put up in the next meeting of the BoG. The Board further directed that in the meantime the advice of the Ministry of Education, Government of India be sought in the matter.

Item No. SPL-2.2: To reconsider the grievance of Technical Assistants regarding their Promotion through DPC-2020.

Resolution No. BoG-SPL-2/2022/04: The Director apprised the Board of the grievance of Technical Assistants regarding their Promotion through DPC-2020. The Board directed that the matter be put up in the next meeting of the BoG scheduled for 24th December 2022.

The Director, MNIT, Jaipur enunciated the noteworthy achievements and steps taken in recent times by MNIT, Jaipur:

- MNIT stood at 4th rank as per the student's choice for admission among 31 NITs.
- Significant improvement in overall opening and closing cut offs for admissions across branches.
- Significant improvement in the Research & Development grants received by MNIT in the ongoing Financial Year.
- Conducted orientation programme for the first year undergraduate students in an innovative way with three days training programme on discipline, plagiarism, sustainable development, inter disciplinary research etc.

The Board commended the Director, MNIT, Jaipur and his team for their enthusiasm and the efforts undertaken by them aimed at reforms in streamlining the rosters and the recruitment process and other crucial aspects of the institute administration.

The Chairman and Prof. Rangan Banerjee suggested enhancing engagement between MNIT, Jaipur and IIT, Delhi and to take steps towards ushering long term mutually beneficial partnership between the two institutions.
