To consider the Professional Fee of Shri R.D.Rastogi, Senior Advocate Additional Solicitor General of India and Shri Nathu Singh Chauhan, Legal Counsel/Advocate on Record for contesting the Arbitration matter titled as KMV Projects Ltd. Vs MNIT Jaipur before the Learned Sole Arbitrator.

The committee accepted the need for hiring a very senior counsel to fight the arbitration process on behalf of MNIT, Jaipur owing to the very large sum of money being claimed by the claimant against the Institute and the reputation of the institute being also involved.

The Finance Committee recommended to the Board to approve the Professional Fee of Shri R.D Rastogi, Senior Advocate Additional Solicitor General of India and Shri Nathu Singh Chauhan, Legal Counsel/Advocate on Record for contesting the Arbitration matter titled as KMV Projects Ltd. Vs MNIT Jaipur before the Learned Sole Arbitrator.

The committee further recommended that a technical team of officials having knowledge of the matter be constituted to assist the learned counsels being hired by the Institute for effective resolution of the case.

The next meeting of the Finance Committee is scheduled to be held on 12th June, 2023.
