



MEMORANDUM OF UNDERSTANDING
between
Malaviya National Institute of Technology, Jaipur
and
Eötvös Loránd University, Hungary



Malaviya National Institute of Technology, Jaipur (seat: Board Room of MNIT Jaipur, represented by: Director, MNIT Jaipur, hereinafter referred to as MNIT Jaipur), and **Eötvös Loránd University** (seat: H-1053 Budapest, Egyetem tér 1-3., Hungary, represented by: Prof. Dr. László Borhy rector, responsible department for exercising the rights and performing the obligations, hereinafter referred to as ELTE), wishing to enhance relations between the two universities and to develop academic and cultural exchange in the area of education and other activities, have agreed to the following:

Article 1:

The Parties increase their academic, scientific and cultural relations in the disciplines of Engineering within the field of education, training, research and administrative community services.

Article 2:

The Parties agree that their cooperation may include but not be limited to the following areas:

- 1) Exchange of researchers
- 2) Exchange of faculty
- 3) Exchange of students
- 4) Transfer of students
- 5) Exchange of staff members
- 5) Summer School
- 6) Exchange of scholarly and pedagogical materials
- 7) Joint research/programs
- 8) Technical assistance and/or training
- 9) Other cooperative efforts as may be specified later

Article 3:

The establishment of the cooperation of the Parties, the programmes and activities, their objectives, costs and achievements should be specified and approved in separated agreements

that should include the general description of the activities, the staff involved, the duration of the specific programme and the financial arrangements and the agreement on intellectual property rights for its implementation. The Parties agree that no obligation (especially, but not limited to the obligation to fund any activity, project or program under the scope of this MOU) may rise from this MOU, unless otherwise specified in a separate, written agreement of the Parties.

Article 4:

The Parties agree that all specific arrangements and plans for activities are to be negotiated and depend on the availability of funds. The Parties will seek funding for the activities defined in this MOU from various sources

Article 5

Any notice to be issued under this MOU shall be in writing to the addresses and recipients listed above. It shall be deemed to have been served when personally delivered or, if transmitted by fax, electronic or digital transmission, when transmitted, provided that such transmission is confirmed by receipt of a successful transmission report and confirmed by mail.

Article 6:

The present MOU enters into force on the day when both Parties have signed it, and will remain in force for five (5) years. Both Parties may terminate this MOU with a six (6) month's prior written notice. This MOU may be amended or modified at any time by mutual consent in writing by both Parties.

Article 7:

MNIT and ELTE shall abide by the policy of equal opportunity in the administration of this MOU and neither institution shall impose criteria for the exchange of scholars or students, which would violate the principles of non-discrimination.

The Parties have signed the present MOU as being consistent with their will and consent.

**Agreement for Student Exchange
Between
Eötvös Loránd University, Hungary
And
Malaviya National Institute of Technology, Jaipur**



Eötvös Loránd University (seat: Egyetem tér 1-3, 1053 Budapest, Hungary), Hungary and **Malaviya National Institute of Technology, Jaipur** (seat: Board Room of MNIT Jaipur, represented by: Director, MNIT Jaipur, India), wish to establish a framework for student exchange programme which will support the promotion of all-round development of students, particularly in the areas of global outlook and cultural appreciation, and hereby agree to the terms and conditions as follows:

1. **Number of Exchanges Students:** Each institution agrees to exchange a total of 1(one) student for one academic year. Overall balance of student units can be achieved during the period of the Agreement. Two students for one semester shall be equivalent to one student for two semesters.
2. **Selection of Students:** It is expected only students of good academic performance will be selected by the home institution. The host institution reserves the right of final approval on the admission of an exchange student.
3. **Credit Transfer:** The home institution shall consider and decide on whether credits earned by their exchange students at the host institutions will be transferred to the students' academic records at the home institution.
4. **Financial Arrangements:** Exchange students shall remain registered as full-time students throughout the exchange period and pay normal tuition fees to the home institution. They will be enrolled at the host institution without having to pay tuition fees. They are responsible for the costs of living, travelling, accommodation, insurance and other incidental expenses.

5. **Accommodation:** The host institution will provide exchange students with all possible assistance in looking for suitable accommodation.
6. **Immigration Formalities:** Each institution will issue appropriate documents for visa purposes in accordance with the current law, although it is ultimately the responsibility of the individual student to obtain a proper visa in a timely manner.
7. **Insurance:** Exchange students are required to arrange their own insurance against illnesses and accidents covering the period of their stay in the country of the host institution.
8. **Students' Obligations and Entitlements:** Exchange students will be subject to the rules and regulations of the host institution. They will be entitled major academic resources and support services generally available to full-time students at the host institution.
9. **Arrival Arrangements:** On arrival in the host country, the host institution will provide the exchange students with appropriate orientation on the host country and institution.
10. **Period of Agreement:** This Agreement will come into effect immediately upon signing. It will be in force for five (5) year and it shall be automatically extended for another term of five (5) years unless one of the Universities requests in writing to withdraw from the Agreement.
11. **Termination of Agreement:** Either party may terminate this Agreement by serving a six-month prior written notice to the other party. Such termination shall not affect the validity and continuity of any incompletely discharged obligation agreed upon by the two parties before termination.
